This paper will analyse the consequences of the "Regional Principle" of the German Savings banks and Credit Unions on the risk concentration in their loan portfolios. One main subject is to show the positive and negative impacts of both strategies, specialization and diversification, on risk concentration, and to explain under which circumstances a bank should decide to specialize or to diversify. Furthermore possibilities will be presented to profit from both strategies thanks to credit risk tranfer by new financial products. The Regional Principle, its origin and and how it determines the strategy of Savings Banks and Credit Unions will be observed in the first part.
